DEPENDENCY: 16 hours of which must include at least:

4 hours of Mediator Ethics,

4 hours of Interpersonal Violence Education

1 hour of Diversity/Cultural Awareness.

APPELLATE: 4 hours of appellate-specific mediation education

This may be part of or in addition to the required 16 hours per renewal cycle of the underlying certification

NOTE: Mediators who are certified in more than one area must complete sixteen hours of CME applicable to each of their areas of certification. Hours completed may be utilized toward more than one area of certification if the subject matter is relevant to each field of certification. For example, courses on such topics as mediator ethics, domestic violence, and general mediation skills may be credited to any or all of the areas of certification.
